#### Who We Are

The Children's Advocacy Center of Paris (CAC) provides the critical services children and their non-offending families need as they go through the criminal justice system. The CAC coordinates the investigation of the most severe cases of child abuse in our community by bringing together the professional agencies that investigate child abuse to form a team that collaborates and shares information so that the child's best interests are kept in mind. Since 1999, the CAC of Paris has worked with Law Enforcement, Child Protective Services, Mental and Medical Health Providers and Prosecutors to help over 3,800 victims of abuse.

We believe that every single child in Lamar & Red River Counties who is a victim of criminal abuse deserves the best we as a society can offer them during times of crisis and trauma: The Children's Advocacy Center (CAC) Model. The benefits of a child-focused, joint investigation are well-documented and recognized by experts, stakeholders and decision-makers alike. **2017 was a year of children in need as the number of children we served increased by 25% to over 220 children.** 

## Services Provided in 2017

## **Specialized Child Forensic Interviews**

Successful outcomes of child abuse cases begins with a thorough investigation. At the core of that investigation is the ability to ensure the safety and protection of children which often starts with the forensic interview. The CAC Forensic Interviewers assists local law enforcement and Child Protective Services investigators by conducting specialized and unique forensic interviews of children who are alleged victims of abuse.

The goal of a forensic interview is to gather pertinent information from children in a neutral, non-leading, developmentally sensitive, and legally defensible manner. The forensic interview process allows partner agencies to observe the interview as it is being conducted. This allows for a collaborative team approach to taking a child's statement, therefore protecting the integrity of the information gathered. The forensic interview is often a critical part of not only the initial investigation but also the criminal prosecution at trial.

In 2017:

- 215 Children received Child Forensic Interviews
- 79% had never been to the CAC before
- 21% were not old enough to attend Kindergarten
- 99% of Children knew & trusted their Perpetrators

Our Mission is to provide hope, healing and justice to child victims of crime in Lamar and Red River Counties.

#### **Trauma-Informed Mental Health**

We are committed to providing a safe place for children and adolescents to begin the healing process after they have experienced abuse or witnessed a violent crime. Our CAC therapist provides long-term, trauma-informed therapy to children of every age. Since child abuse affects the whole family, the services provided at the CAC are available at no cost to every child and their non-offending family members. When a child comes to the CAC for a forensic interview, they are eligible for therapy services. Our CAC therapist provides Trauma-Focused Cognitive Behavioral Therapy which is considered Best Practice for use with abused and traumatized children to help them heal from the abuse they have experienced.

- 49 Child victims received 345 free counseling sessions
- 33 Non-offending parents received 149 free counseling sessions

## **Key Accomplishments in 2017**

#### **NCA Re-Accreditation**

Every five years nationally accredited CACs undergo a lengthy re-accreditation process. In 2017 we earned our re-accreditation with the National Children's Alliance (the national accreditation for Children's Advocacy Centers) under their newly released higher standards.

#### A Refocus on our Multi-Disciplinary Team

From the very beginning, the multi-disciplinary team (MDT) has been the heart and soul of the CAC concept, bringing together our local CPS investigators, 6 local law enforcement agencies, our district and county attorneys offices, juvenile probation, local mental health counselors and our specialized medical personnel in pursuit of justice and healing. Born out of the realization that collaboration and information sharing among agencies was critical to successful outcomes in these complex cases, the MDT approach has been recognized nationally as a best practice in the intervention and investigation of child abuse cases. Our relationship and role with our partner agencies and professionals not only informs how we approach every aspect of this work, but is also a differentiating factor for the CAC model.

#### **New Texas Family Code Mandate**

The Texas Legislature again showed that child victims of abuse are a priority by passing Senate Bill 1806 into law which mandates a CAC/ MDT response to the most severe reports of child abuse.

#### **CACTX Women of Courage My Safe Space: A Room Makeover Project**

CAC Paris was awarded \$1,000 to help restore a child's living space after abuse. We were honored to complete our first room makeover project in 2017.
